


Interconnections





Interconnections:


- **EE-LV = 2 interconnections**
- LV-LT = 4 interconnections
- LV-RU = 1 interconnection
- **EE-FI = 2 interconnections**

Projects of Common Interests (PCI)



• On 14 October 2013, the European Commission has adopted the first list of 248 PCIs, and the list of PCIs will be updated every two years

PUC decisions regarding the allocation of investment costs:

- PUC decision on April 9, 2014, No.77 on Internal Line between Ventspils, Tume and Imanta (LV)
- PUC decision on April 23, 2014, No.90 on Interconnection between Kilingi–Nõmme (EE) and Riga TEC 2 Substation (LV) and Internal Line between Harku and Sindi (EE)

In accordance with CEF :

- 3rd EE-LV interconnection received financial support of 65% of total costs
- 3rd Stage of Kurzeme Link received financial support of 45% of total costs
- Second PCI list will be accepted at the end of 2015, additionally there are included projects from «Baltic corridor» for increase of capacity of 600MW:
 - Internal line Rīgas TEC2 Rīga HES as reinforcement of 3rd EE-LV interconnection
 - Replacement of 330kV interconnection lines Tartu(EE) Valmiera (LV) and Tsirgulina (EE) Valmiera (LV)


Independent electricity system operator ISO – TSO certification



- On January 30, 2013 PUC completed a certification of an independent electricity system operator ISO - JSC "Augstsprieguma tīkls" (TSO)
- On February 1, 2015 JSC "Augstsprieguma tikls" completed all conditions of certification decision, and TSO has taken over the following functions of commercial activity from JSC "Latvijas elektriskie tikli":
 - Service and maintenance of transmission system assets;
 - Development of transmission system, construction of new networks, rebuilding and refurbishment of existing networks.

Case subject: Case relates to high price peaks in all Baltic countries




PUC conclusion: Coincidence of technical circumstances simultaneously in all three Baltic countries, Russia and Belarus. As a result – **lack of capacity** and high price peaks

Market surveillance in 2014 (1)




Case No.2: Case relates to high price peaks during July and August, 2014

PUC conclusion: Price peaks appeared because of phenomenon called **«Paradoxically rejected block bid»**


CEREMP, REMIT



- CEREMP registration status: 14 MP registered
- October 7, 2015: data collection started (ACER)
- NRA co-operation:
 - Nord Pool Spot Regulatory Council
 - Market Monitoring Expert Sub-group of Nord Pool Spot Regulatory Council
 - Nord Pool Spot Regulatory Council Fundamental Transparency Regulation expert Subgroup
 - Common Nordic-Baltic Wholesale Market monitoring and common UMM monitoring
